Proceedings of the meeting:

1. The IQAC coordinator thanked one and all for the achievement of the 'A' grade in the NAAC 1st cycle. However, he expressed that the Areas of Concerns reported by the Peer team must be addressed in a phased manner. The discussion then centred on the critical evaluation of the report.
2. The Dean Research and Allied Health Sciences expressed that it is feasible to implement competency based innovative curriculum and CBCS in all the new programmes soon.
3. He also stated that the Faculty are being provided incentive for publications etc; may be this system will be enhanced in future.
4. The Vice Chancellor stated that all the institutions' Heads must improve research publications, consultancy and collaborations.
5. He also stated that the educational units must conduct more faculty development programs.
6. The IQAC must start the AAA process either internal or external with effect from this year. In this regard, IQAC must prepare a SOP/ manual for AAA process.
7. The hospital and lab in charges must commence the process of NABH and NABL accreditations. The vice chancellor also stated that the next five-year plan must include strategies addressing these areas of concern.
8. The QER reports of Oct- Dec was presented by the IQAC coordinator. The data compiled in that quarter was satisfactory as it included the compilation of data for the SSR of first cycle NAAC in Nov'15.



9. Quality program planned for February & March were presented which included program done in association with MEU & NEU. The Vice Chancellor stated that IQAC can also conduct programs on quality related to focus independently.
10. IQAC coordinator thanked one and all and informed all that the next meeting will happen after the next QER of Jan- Mar quarter.
