Minutes of the meeting:

1. The landmark MoU signed between Partners Medical International (Harvard) and

SBV on March 19th, 2016. This MoU was signed to enhance the academics, teaching-

learning-assessment and administration aspects of SBV.

2. In this regard A series of FDP was conducted by the resource persons of PMI for all

faculty across disciplines. The FDPs happened between April 2nd week to last week.

Topics included Education Reforms, Vision Mission, Planning a Project, Instructional

Design and the Roles of Faculty. The faculty of SBV participated enthusiastically. The

Vice Chancellor expressed that this is a constructive start towards overcoming the

weaknesses of SBV as mentioned in the last NAAC.

3. The IQAC coordinator reported quality program done in February and March. The

topic included - Rockefeller habits, Choice Based Credit Grading System, Goal

Setting- Benchmarking and perspective planning. He also highlighted the National

program done in Chronobiology and Health, the Quality initiative in Competency

Based Medical Education for PG training, by MEU in association with IQAC. The

members appreciated the programs done by IQAC specifically on quality.

4. The Dean Research and Allied Health Sciences informed the floor that Choice Based

Credit System has been approved by the Academic Council to be implemented in
