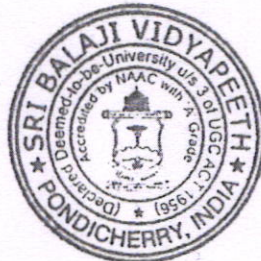

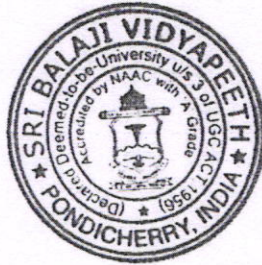

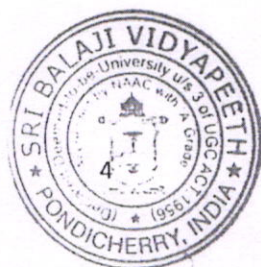

The Hon'ble Vice Chancellor called the 29th meet of the Board of Management to order. In his opening remarks, he highlighted the fact that the Board of Management would be reconstituted with effect from January 2020. Elaborating further, he emphasized on the cardinal role of the Board of Management since it is an apex body governing all policy matters pertaining to academics, research, health care, extension, outreach activities and administration of the University. While welcoming all the members of the Board to the 29th meeting, he expressed his sincere thanks to the three nominees of the Sponsoring trust for having made to the meeting. Before the proceedings began, the Vice Chancellor invited the eminent members for their opening remarks.

On a personal note, Prof. Ved Prakash Mishra, recipient of the prestigious BC Roy award eulogized the dynamism and stature of the Vice Chancellor, SBV. Dr. Mishra felt gratified at the fact that SBV has made rapid strides especially during the last year that would bear ample testimony to the strong leadership and the single minded devotion, dedication and commitment of the hard working faculty and administration. Prof. Mishra recorded his deep sense of satisfaction and acknowledged the kindness of the Hon'ble Chancellor and Hon'ble Vice Chancellor of SBV which have resulted in activities related to a greater cause and for the larger benefits of the community. Continuing with his remarks, Dr. Mishra drew references to the fact that the visibility of any higher education institution would gather significance only if the visibility of the University is linked to societal commitment and cause. In order to facilitate translational research which is the need of the hour, focused and specialized team effort coupled with a good ambience are pre-requisites to a model health sciences university. SBV is poised to scale greater heights. Dr. Mishra informed the Board that his services would always be made available to enhance the perception of SBV in particular and higher education institutes in the country, in general.

Dr. S.R. Rao, Nominee of the Sponsoring trust cherished his long association with the Vice Chancellor and Dr. Mishra that is presently continuing under the umbrella of the BoM. Dr. Rao remarked that education, research and patient care constitute a conglomerate. In the light of this access to biological samples is a crucial phenomenon which in combination with medical professionals at the interface would provide the most optimal environment. It is in the fitness of things that the School of Biological Sciences has been created under the same ambit of a health sciences university. Freedom to operate and confluence of disciplines with the onus on industry, academia collaboration and entrepreneurial skills would continue to flourish under the banner of School of Biological Sciences at SBV.

Dr. Krishna G. Seshadri, Nominee of the Sponsoring trust highlighted the fact that the Vision of SBV management is to give equal impetus to the four verticals namely academics, research, patient care, consultancy and extension services. Most importantly hospitals not providing effective patient care cannot improve the overall efficiency. Hence there is an immediate need to build on these verticals a cohesive unit.

Prof. Subhash Chandra Parija, the Vice Chancellor and the Chairman of the Board of Management, SBV asked the Registrar, SBV to present the agenda wise. Registrar tabled the agenda item wise for deliberations,

PRESENTATION BY THE VICE CHANCELLOR

VISION 2025—SBV PERSPECTIVES

The Vice Chancellor made a succinct power point presentation on “SBV Milestones” that have been reached thus far and the important aspects in the light of *Vision 2025*. The vice Chancellor presentation centered on the aspiration of the management to take research into greater heights. Intellectual Property Rights associated initiatives have never been the prerogative of a health sciences university. However SBV wants to forge ahead with Copyrights, Patents and Technology transfer – *hitherto* less visited areas. SBV would like to figure among the top 10 higher education institutes in the country as far as IPR activities are concerned. In this direction, the copyright as well as patent sensitization and comprehensive workshop are being continually facilitated. Several innovative and value based academic courses and programmes have been started at SBV which includes interdisciplinary courses and one year full time fellowship programmes. Continuing with his presentation, Vice Chancellor added that SBV has done itself proud by devising 23 Faculty Development Programmes – all aimed at Capacity Building. This is an unique endeavor since it would involve professionals from diverse fields and with an international flavor. Proceeding further, the Vice Chancellor informed the Board that SBV is one among the few health sciences universities having Four in-house journals. In order to disseminate scientific knowledge to the global community and also enhance the perception, visibility of SBV. These journals are now being published by JP Publishers, a big name in the Indian publishing house. Yet another important facet of the Vice Chancellor presentation was the unique portal for promulgating self-sustainable endeavours. *Vision 2025* assumes great relevance in view of the expanding global domain. Mention must be made of the multifaceted sustainability for the next five years and all these activities should endear themselves with at most patient care, patient safety and ethical practice synonymous with a care – smile model by year 2025.

The Vice Chancellor’s presentation drew the attention of the members of the BoM to the variegated academic activities that are promulgated under the purview of regulatory agencies as well as under the power of academic flexibility vested with the deemed –to-be-Universities. SBV has been accredited with A Grade by NAAC and is ranked 72 as per NIRF rankings 2019.

One of the unique features of SBV is the starting of the Faculty development Programs that has already resulted in national success within a short span of time. The FDPs have been planned in the various domains, namely Academics, Research, Patient care and industry-academia.

A nodal initiative is the incorporation of a transgender inclusive curriculum across the UG and PG programs in nursing. This is the first of its kind in the country towards the contribution of INSTITUTE SOCIAL RESPONSIBILITY. The program has already attracted the attention of several HEIs.

Biological sciences make a huge impact on medical sciences and with this in view, the School of Biological sciences has been started w.e.f Year 2020. This would open newer vistas in higher education with the focus on managerial skills and academia-industry collaboration/entrepreneurship. Small animal Research facility propelled by DBT, Govt. of India is yet another unique endeavour.

There has been a spurt in research publications. In the period Jan to Sep 2019, 564 publications in indexed journals have been enabled. Since the inception of SBV nearly five thousand publications have arisen.

IPR related activities are less frequently visited in health sciences deemed to be university. SBV, through MIPTECH, the mission for technology transfer has been successful in publishing copyrights and patents. Mention must be made of 34 patents and 128 copyrights till date. SBV has spent an amount of Rs.30 lakhs to facilitate this IPR related activities.

The strategic initiative for developing capacity in ethical review (SIDCER) has accorded the international recognition to IHEC of MGMCRI, namely FERCAP status.

The reinforced telemedicine facility inaugurated by Prof. Gurmeet Singh, the Hon'ble VC of Pondicherry University in January 2019 is presently offering dedicated service. Yet another patient centric initiative is the TWO WHEELER mobile service to remote areas for the benefit of non ambulatory patients. Recently, MGMCRI hospital has been recognized by the Ministry of Health and family welfare for conducting organ transplantation .

Several MoUs were signed during the one year period that foster developmental activities in academics, health care, besides research and extension services.

Knowledge tree is a unique activity aimed at PERCEPTION. Under the KNOWLEDGE TREE, eminent persons from diverse walks of life are invited to share the views. The inaugural edition witnessed the interesting conversation with Sri Manoj Das, a recipient of Padma Shri.

MGMCRI hospital has been endowed with entry level NABH accreditation. IGIDS, a constituent college of SBV figures among the 40 top dental colleges of our country. Red Ribbon Club of KGNC has been nominated as one among the top five institutes from the Union Territory of Puducherry.

The visibility of SBV has enhanced over the years and recently that is manifest in SBV being nominated as the State coordinating University by UGC to coordinate the year long activities commemorating the 70th anniversary of Indian Constitution.

The Vice Chancellor concluded his succinct presentation by quoting "Universities should show the way to society"

The Vision 2025 of SBV presented by the Vice Chancellor Prof. Subhash Chandra Parija was approved and ratified. A committee is to be constituted under the chairmanship of the Vice Chancellor as suggested by BOM to refine and finalise the Vision 2025 and be presented at the ensuing 30th meeting of the Board of Management.

The Vice Chancellor completed his presentation by highlighting on the sustained developmental initiatives aimed at holistic health care and societal development.
