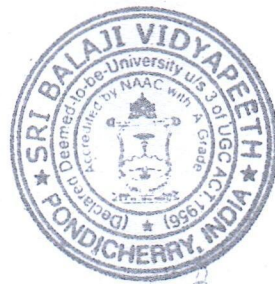

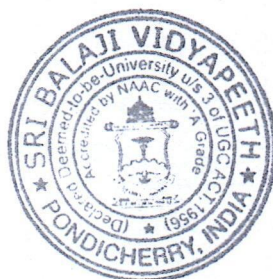

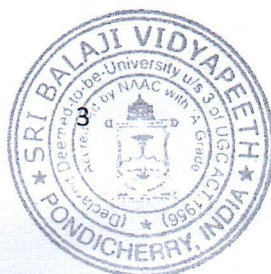

The 30th Academic Council Meeting of Sri Balaji Vidyapeeth was held virtually on ZOOM platform on **28st September 2020** between 2.00 pm and 4.30 pm under the Chairmanship of Prof. Subhash Chandra Parija, Hon'ble Vice-Chancellor of SBV.

The Vice Chancellor accorded a hearty welcome to the esteemed members of the Academic Council and thanked Prof. S.P. Thyagarajan, Professor of Eminence & Dean – Research from Sri Ramachandra Institute of Higher Education & Research, Chennai for his participation. The Vice Chancellor explained in brief about the significance of SBV Academic Council which determines the academic activities occurring at the constituent colleges and centres. Furthermore he added the Academic Council would be entrusted with specific tasks that would be assigned based on institute need and guidance of the various committees in place.

Before asking the Registrar to present item wise agenda of the 30th meeting of the Academic Council, the Vice Chancellor requested the Professor of Eminence, Prof. S.P. Thyagarajan to offer his opening remarks.

Prof. S.P. Thyagarajan expressed his satisfaction at the manner in which the Prof. S.C. Parija, Vice Chancellor, SBV has been conducting the endeavours of the Academic Council of SBV and also complimented the Registry for the meticulous preparations leading to the effective conduct of the meetings of the Academic Council and remarked that the Vice Chancellor plays a pivotal role in the objectivisation of academic deliberations. Adding furthermore, Prof. Thyagarajan made a noteworthy mention of the introduction of several innovative, skill based and value added programmes at SBV. In this connection he drew the attention of the Council to the National Education Policy (NEP) 2020 which lays due emphasis on the implementation of novel, vocational and problem based courses and academic programmes. However caution has to be exercised while objectively addressing related key points including situation / need-analysis, demand for the programme besides employability of the candidate. In this connection, comprehensive data has to be compiled which should promote the dissemination of these programmes among the students both nationally and internationally with the thrust being duly laid on skill based programmes. Furthermore job oriented programmes on the lines of those that are enumerated by the Health Sector Skill Council need to be offered at SBV with specific considerations for the socially and economically deprived student community. Also, such programmes warrant specialized infrastructure and laboratory. It is highly recommended to revisit the recommendations to be provided by the General Body of Health Sector Skill Council in October 2020. Another facet is ample provision for inculcating communication skills which is a need of the hour, especially at time when globalization of education and educational perspectives are in force.

The Vice-Chancellor, Prof. S.C. Parija asked the Registrar, Prof. A.R. Srinivasan to present the item wise agenda for deliberations.

Registrar, Prof. A.R. Srinivasan before proceeding with the agenda pertaining to the 30th Academic Council meeting, tabled the minutes of the 29th meet of the Academic Council, which was already circulated to all members. The council unanimously resolved to approve of the minutes circulated.

Further the Action Report pertaining to 29th Academic Council meeting held on 21st November 2019 was tabled. The Action Report was unanimously approved by the council.

General comments, observations, suggestions and Academic initiatives:-

- M.Phil., programme has been withdrawn because PhD is the entry level qualification for even the faculty working in Arts and Science Colleges.
- While integrated M.Sc programme in Biological Sciences is a welcome addition, programmes such as PhD (Direct) following completion of UG degree can also be explored.
- Greater number of PhDs should be inducted to fortify the activities of Evidence based Research in the clinical and applied sciences.
- Hybrid mode of imparting Education can be implemented in such of those areas where innovative, skill enhancement and capacity building are visualized.
- While developing strategies for programmes designed uniquely at SBV care must be taken to convert such programmes into Quality based academic endeavours that would attract the National and International student community alike.
- Use of the term, 'SBV Credits' is to be discontinued as SBV is just following the UGC mandated protocol which states 16 hours of direct contact teaching / 32 hours of practical / 32 hours of self-directed learning (Heutagogy) corresponds to 1 credit (as per UGC). Care must be taken to space the credits evenly for a period of one year in Diploma and Fellowship programmes. This would also enable SBV to conduct such academic programmes leading to the Academic Bank wherein the credits would be recognized globally.

Closing remarks by Honorable Vice Chancellor:

The Hon'ble Vice Chancellor of SBV, Prof. S.C. Parija, thanked the members of the Academic Council in general and especially the External member, Prof. S.P. Thyagarajan for his valuable inputs that would guide SBV in launching several unique programmes in academics and research, besides those programmes that come under the immediate purview of the statutory councils and regulatory bodies. It is noteworthy to mention that the deliberations at this meeting would go a long way in realizing the optimal potentials of SBV and more so in the light of the National Educational Policy 2020 and also the revised UGC Regulations 2020 on Online classes and Distance Education.

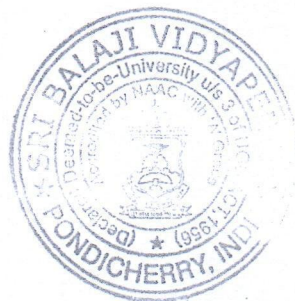
