

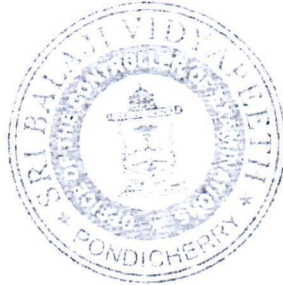

Report of Examination section, SBV  
2015-16

The university examinations of Sri Balaji Vidyapeeth (Constituent colleges and centers) are conducted by the Examination division of SBV in accordance with the Academic calendar approved by the Board of Examinations. The meeting of the Board of Examinations for the academic year 2015-16 was held under the Chairmanship of Prof.K.R. Sethuraman, Vice-Chancellor of SBV, on 23.02.2015 (refer to **Annexure 2**). Dr. Srirangaraj S, Controller of Examinations, presented the tentative schedule of SBV university examinations for the academic year 2015-16 for the undergraduate and postgraduate programs. The Academic calendar was approved by the Board.

Question paper sets were received in encrypted format from external subject experts for both undergraduate and postgraduate programs. Examination division of SBV completed scrutiny of these question paper sets by a panel of subject experts and made the suggested revisions before the selected sets were used for university examinations during 2015-16.

Examination division of SBV conducted examinations for 86 programs during 2015-16 academic year (refer to **Annexure 1**). A total of 3108 students appeared for examinations during 2015-16. As per the directions of Vice-Chancellor, SBV, internal and external examiners were appointed from various colleges. Central valuation was conducted for evaluation of theory answer scripts. Results were declared as per the norms of the regulatory bodies. On an average, the number of days taken to declare results from the last day of examination was limited to 10.9 days. The average pass percentages were 74% and 85% in undergraduate and postgraduate final year students respectively (refer to **Annexure 4**).

After the publication of results, Controller of Examinations, SBV issued notification regarding therevaluation / retotalling dates so that aggrieved students can apply for reevaluation and retotalling. The grievances received for the examinations conducted during 2015-16 pertain to reevaluation only. Examination division of SBV received reevaluation

application from 397 students (MBBS: 331, BDS: 54, BSc Nursing 12) in 2015-16. In case of 28 candidates, the marks obtained by the candidate during his/her first appearance in the university examinations was changed in the result outcome after revaluation. The Evaluation Grievance Redressal Committee met under the Chairmanship of Prof. Ananthkrishnan N, Dean - Research & AHS, SBV on 24.11.2015, 03.03.2016, 27.06.2016 and 11.11.2016. In the final meeting held on 11.11.2016, the Committee reviewed the status report of revaluation/retotalling submitted by the Controller of Examinations, SBV pertaining to the University examinations conducted during August 2015-July 2016 and certified that due process of redressal of grievances had been carried out for the aforementioned period (refer to Annexure 3).

The pre-examination, examination and post-examination processes of Examination division have been computerized using various software. SBV Garuda, an in-house software, was used for student registration, hall ticket generation and result declaration as well as for online submission of practical and viva marks. To ensure security and confidentiality, bar coded answer booklets were used for theory examination. The student information sheets and marks given by examiners in the answer scripts were scanned and read with the help of Fujitsu fi-612 scanner and Verificare software.

The Vice-Chancellor requested the Controller of Examinations, SBV to submit the status report of the examinations held during the year 2014-15.

The Controller of Examinations, Dr. Srirangaraj S, presented the status report of University Examinations held during the academic year 2014-15. The trend analysis of



the results declared as on date was placed for different courses under the Faculty of Medicine, Dentistry, Nursing Sciences and Allied Health Sciences. The Board accepted the status report unanimously.

The Controller of Examinations, placed before the Board, the tentative schedule of SBV University Examinations for the academic year 2015-16 in the form of examination calendar for all the courses. The Postgraduate examinations for regular batches are scheduled to start in the month of April 2015 with MD/MS/Diploma examinations, followed by MDS examinations in May 2015. The Medical Undergraduate examinations, i.e. II MBBS, III MBBS- Part I, III MBBS- Part II (Faculty of Medicine), will commence in the month of June 2015. BDS examinations (Faculty of Dentistry) will be held during the month of July 2015, whereas, B.Sc, PBB.Sc & M.Sc Nursing examinations (Faculty of Nursing Sciences) will be held during August 2015. The B.Sc (AHS) will start in the month of September 2015.

The Examination calendar for all the courses for the Year 2015-16 was approved by the Board of Examinations and Controller of examinations assured that the corrections suggested will be incorporated and the final schedule will be placed for the approval of the Vice-Chancellor and then circulated to the respective heads of the various institutes.

The Controller of Examinations, placed the consolidated list (Panel) of Examiners (External) of Faculty of Medicine, Dentistry, Nursing Sciences & Allied Health Sciences, as forwarded by the respective Board of Studies in its recent meetings held. After the detailed discussion, the Panel of Examiners were approved by the Board of Examinations of the respective Faculty.
