

## Report of Examination section, SBV

2016-17


Examination wing, SBV conducts university examinations of Sri Balaji Vidyapeeth (Constituent colleges and centers) in accordance to the Academic calendar approved by Board of Examinations. Dr. Srirangaraj S, Controller of Examinations, presented the tentative schedule of SBV university examinations for the academic year 2016-17 for undergraduate and postgraduate programs in the meeting of the Board of Examinations, held under the Chairmanship of Prof. K.R. Sethuraman, Vice-Chancellor of SBV on 18.01.2016 (**refer to Annexure 2**). The members of the Board unanimously approved of the Academic calendar.

Examination wing, SBV conducted examinations for 59 programs during Aug 2016-May 2017 (**refer to Annexure 1**). A total of 2497 students appeared for examinations during aforementioned period. Question paper sets received in encrypted format from external examiners were scrutinized by a panel of subject experts to validate the technical correctness and suitability of the question papers as per the blueprint. The revisions suggested by the experts were completed and the chosen sets were utilized for university examinations during 2016-17. As per the directives of the Vice-Chancellor, Examination wing, SBV appointed of internal and external examiners from various institutes for the conduct of theory and practical examinations. Central valuation was conducted for evaluation of theory answer sheets. Results were declared as per the norms of the regulatory bodies. The average number of days taken to declare results from the last day of examination was 12.8 days. The average pass percentages were 74% and 93% in undergraduate and postgraduate final year students respectively (**refer to Annexure 4**).

After the publication of results, the students were given the provision to apply for revaluation and retotalling. Controller of Examinations, SBV issued notification regarding the revaluation / retotalling dates. The students grievances received for the examinations conducted during 2016-17 pertain to revaluation only. A total of 173 students (MBBS: 155, BDS: 13, Nursing 5) applied for revaluation of answer scripts in 2016-17. The marks

obtained by the candidate during his/her first appearance in the university examinations have not changed in the result outcome after revaluation except for 10 candidates. Controller of Examinations, SBV submitted the status report of revaluation/retotalling pertaining to the University examinations conducted during Aug 2016-May 2017 to the Evaluation Grievance Redressal Committee on 09.05.2017. The committee met thrice under the Chairmanship of Prof. Ananthkrishnan N, Dean - Research & AHS, SBV on 21.12.2016, 25.02.2017 and 19.05.2017. In the final meeting held on 19.05.2017, the Committee reviewed the status report of revaluation/retotalling and endorsed that due process of redressal of grievances had been carried out for the aforementioned period (refer to Annexure 3).

At SBV, various software have been in use for efficient and smooth functioning of the various activities of the Examination wing. SBV Garuda, an in-house software, was used for student registration, hall ticket generation and result declaration as well as for online submission of practical and viva marks. Verificare software and Fujitsu fi-612 scanner were utilized to read the student information sheets and marks given by examiners. Answer books with inbuilt bar-coded student information sheet and evaluation sheets were used to ensure confidentiality. Post-validation or question-wise analysis of students' performance in theory examinations was initiated by Examination wing, SBV for MBBS in 2014. Post-validation was introduced for Dental & Nursing undergraduate programmes in the academic year 2016-17.
