

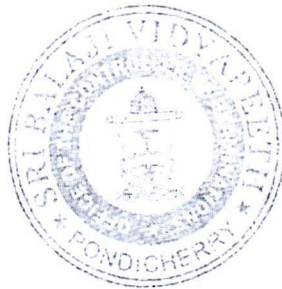

Report of Examination section, SBV

2017-18

The university examinations of Sri Balaji Vidyapeeth (Constituent colleges and centers) are conducted by the Examination division of SBV in accordance to the Academic calendar approved by Board of Examinations. The meetings of the Board of Examinations for undergraduate and postgraduate programs for the academic year 2017-18 were held under the Chairmanship of Prof.K.R. Sethuraman, Vice-Chancellor of SBV, on 16.12.2016 (**refer to Annexure 2**). Dr. Srirangaraj S, Controller of Examinations, presented the tentative schedule of SBV university examinations for the academic year 2017-18 for the undergraduate and postgraduate programs. The Academic calendar was approved by the Board.

Examination wing of SBV conducted examinations for 141 programs during June 2017-July 2018 (**refer to Annexure 1**). A total of 3288 students appeared for examinations during 2017-18. Question paper sets were received in encrypted format from external subject experts for various programs under the faculty of Medicine, Dentistry, Nursing and Allied Health Sciences. These question paper sets were scrutinized by a panel of subject experts selected by Vice-Chancellor, SBV. Suggested corrections were made before the selected sets were used for university examinations during 2017-18.

As per the directions of Vice-Chancellor, SBV, internal and external examiners were appointed from various institutes. Central valuation was conducted for theory paper evaluation. Results were declared as per the norms of the regulatory bodies. On an average, the number of days taken to declare results from the last day of examination was limited to 11 days. The average pass percentages were 75.2% and 88.5% in undergraduate and postgraduate final year students respectively (**refer to Annexure 4**). Post-validation of the question papers by question-wise analysis of students' performance in UG theory examinations was carried out by the heads of the medical, dental and nursing colleges with the help of students' performance data shared by the Examination wing, SBV.

Revaluation / retotalling is an integral component of evaluation grievance redressal mechanism at SBV. Controller of Examinations, SBV issued notification regarding the revaluation / retotalling dates after the publication of results. The grievances received for the examinations conducted during 2017-18 pertain to revaluation only. Examination division of SBV received revaluation application from 144 students (MBBS: 121, BDS: 23) in 2017-18. There was no cases where the marks obtained by the candidate during his/her first appearance in the university examinations have changed in the result outcome after revaluation. The Evaluation Grievance Redressal Committee met under the Chairmanship of Prof. M. Ravishankar, Dean –MGMCRI on 25.10.2017, 07.02.2018, 28.05.2018 and 09.08.2018. In the fourth meeting held on 09.08.2018, the Committee reviewed the status report of revaluation/retotalling submitted by the Controller of Examinations, SBV pertaining to the University examinations conducted during June 2017-July 2018 and certified that due process of redressal of grievances had been carried out for the aforementioned period (**refer to Annexure 3**).

At SBV, various software have been in use for efficient and smooth functioning of the various activities of the Examination wing. In addition to the existing software (namely, SBV Garuda and Verificare), ADMEN, a new software was procured and introduced for reading MCQ answer sheets in 2017-18 academic year.

The trend analysis of the results declared as on date was placed for different courses under the Faculty of Medicine, Dentistry, Nursing Sciences and Allied Health Sciences. The Board accepted the trend analysis and the Vice-Chancellor wanted the trend analysis of the undergraduate examinations need to be circulated to all the concerned Undergraduate departments. The Vice-Chancellor wanted the Controller of Examinations for prevalidation and post validation of the Question papers of the UG Courses.

The Controller of Examinations, placed before the Board, the tentative schedule of Examinations for the academic year 2017-18. The Undergraduate exams (MBBS- Part III, IV) is scheduled to start in the month of June 2017, MBBS - Part II, I) will be held during August 2017 for the courses under Faculty of Medicine and BDS will be during July 2017, Faculty of Dentistry. The B.Sc (AHS) will start in the month of September 2017. Also the Controller informed that the first batch of B.Sc AHS students are expected to take up their examinations in September 2017.
