Report of Examination section, SBV 2018-19

The university examinations of Sri Balaji Vidyapeeth (Constituent colleges and centers) are conducted by the Examination division of SBV in accordance to the Academic calendar approved by Board of Examinations. The meetings of the Board of Examinations for undergraduate and postgraduate programs for the academic year 2018-19 were held under the Chairmanship of Prof.K.R. Sethuraman, Vice-Chancellor of SBV, on 30.03.2018 (refer to Annexure 2). Dr. Srirangaraj S, Controller of Examinations, presented the tentative schedule of SBV university examinations for the academic year 2018-19 for the undergraduate and postgraduate programs. The Academic calendar was approved by the Board.

Question paper sets were received in encrypted format from external subject experts for both undergraduate and postgraduate programs. Examination division of SBV completed scrutiny of these question paper sets by a panel of subject experts and made the suggested revisions before the selected sets were used for university examinations during 2018-19. For the first time, scrutiny of MCQ Question papers was conducted in digital mode in the academic year 2018-19.

Examination division of SBV conducted examinations for 132 programs during 2018-19 academic year (refer to Annexure 1). A total of 3060 students appeared for examinations during 2018-19. As per the directions of Vice-Chancellor, SBV, internal and external examiners were appointed from various colleges. Central valuation was conducted for evaluation of theory answer scripts. Results were declared as per the norms of the regulatory bodies. On an average, the number of days taken to declare results from the last day of examination was limited to 8.9 days. The average pass percentages were 67% and 83% in undergraduate and postgraduate final year students respectively (refer to Annexure 4). Post-validation analysis of UG theory examinations was carried out by the heads of the





medical, dental and nursing colleges with the help of students' performance data shared by the Examination wing, SBV

After thepublication of results, Controller of Examinations, SBV issued notification regarding therevaluation / retotalling dates so that aggrievedstudents can apply for revaluation and retotalling. The grievances received for the examinations conducted during 2018-19 pertain to revaluation only. Examination division of SBV received revaluation application from 266 students (MBBS: 190, BDS: 71, Nursing: 5) in 2018-19. In case of 22 candidates the marks obtained by the candidate during his/her first appearance in the university examinations have changed in the result outcome after revaluation. The Evaluation Grievance Redressal Committee met under the Chairmanship of Prof. M. Ravishankar, Dean –MGMCRI on 27.11.2018, 04.03.2019, 04.06.2019 and 12.12.2019. In the fourth meeting held on 12.12.2019, the Committee reviewed the status report of revaluation/retotalling submitted by the Controller of Examinations, SBV pertaining to the University examinations conducted during Aug 2018-July 2019 and certified that due process of redressal of grievances had been carried out for the aforementioned period (refer to Annexure 3).

Various software have been in use for efficient and smooth functioning of the various activities of the Examination wing. While purchased software like Verificare and Admen were used for reading student information sheets and mark sheets of answer booklets and MCQ responses respectively, SBV Garuda, an in-house software, was utilized for student registration, hall ticket generation result declaration and online submission of practical and viva marks.


