# Report of Examination section, SBV 2019-20

The university examinations of Sri Balaji Vidyapeeth (Constituent colleges and centers) are conducted by the Examination division of SBV in accordance to the Academic calendar approved by Board of Examinations. The meetings of the Board of Examinations for the academic year 2019-20 for programs under Faculty of Medicine and Faculty of Allied Health Sciences were held on 11.04.2019 and for programs under Faculty of Dentistry and Faculty of Nursing were held on 12.04.2019. these meetings were held under the Chairmanship of Prof. S.C. Parija, Vice-Chancellor of SBV (refer to Annexure 2). Dr. Srirangaraj S, Controller of Examinations, presented the tentative schedule of SBV university examinations for the academic year 2019-20 for these programs. The Academic calendar was approved by the Board.

Examination wing, SBV conducted examinations for 143 programs during August 2019-Nov 2020 (refer to Annexure 1). A total of 2759 students appeared for examinations during 2019-20. Question paper sets were received in encrypted format from external subject experts for both undergraduate and postgraduate programs. Examination division of SBV completed scrutiny of theory question papers and MCQ sets by a panel of subject experts and made the suggested revisions before the selected sets were used for university examinations during 2019-20. Examination wing, SBV introduced scrutiny of theory question papers in digital mode and registered a copyright its format. Examination wing also registered another copyright for a new filing system for archiving of documents.

As per the directions of Vice-Chancellor, SBV, internal and external examiners were appointed from various colleges. Central valuation was conducted for evaluation of theory answer scripts. Results were declared as per the norms of the regulatory bodies. On an average, the number of days taken to declare results from the last day of examination was limited to 10.5 days. The average pass percentages were 73% and 92% in undergraduate





and postgraduate final year students respectively (refer to Annexure 4). Post-validation analysis of UG theory examinations was carried out by the heads of the medical, dental and nursing colleges with the help of students' performance data shared by the Examination wing, SBV.

After the publication of results, Controller of Examinations, SBV issued notification regarding the revaluation / retotalling dates so that aggrieved students can apply for revaluation and retotalling. Examination division of SBV received revaluation application from 283 students (MBBS: 247, BDS: 13, Nursing: 23) in 2019-20. In case of 44 candidates the marks obtained by the candidate during his/her first appearance in the university examinations have changed in the result outcome after revaluation. The Evaluation Grievance Redressal Committee met twice on 03.02.2020 and 02.12.2020. In the final meeting held on 02.12.2020 under the chairmanship of Prof. Seetesh Ghose, Dean (I/C) –MGMCRI, the Committee acknowledged that four BDS students were provided access to their answer scripts as per their applications. This was in accordance to the newly introduced procedure for providing access to answer scripts as a grievance redressal mechanism. The committee also reviewed the status report of revaluation/retotalling submitted by the Controller of Examinations, SBV pertaining to the University examinations conducted during Aug 2019-Nov 2020 and certified that due process of redressal of grievances had been carried out for the aforementioned period. (refer to Annexure 3).

The pre-examination, examination and post-examination processes of Examination division have been digitized and automated using various software. Purchased software like Verificare and Admen as well as SBV Garuda, an in-house software, were utilized for efficient and smooth functioning of the various activities of the Examination wing. As a part of reforms in examinations, On-screen Evaluation of answer scripts was introduced for selected programs in 2019-20 as an adjunct to conventional evaluation.




