

The year 2016-17 was an active year for IQAC in the wake of a plethora of quality initiatives in education domain. The spirit of SBV soared high after being ranked in NIRF within 100 in India (93rd Position) in the maiden participation in 2016.

That had invigorated the team to strategize to the minutest details to obtain 83rd ranking in NIRF 2017. While such external ranking provided a glimpse of where SBV stands at National level, the Academic Administrative Audit commenced this year, gave internal perspectives on the process and performances.

This year a conference on Medical/ Dental Education, and numerous FDP on education technology in association with Partners Medical International improved the quality of the faculty across disciplines. Introduction of the 'eportfolio; into the Competency based Medical PG program was a millstone this year.
