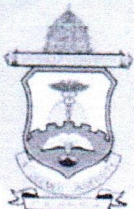

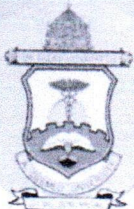

- ✓ The strategic perspective plan for 2018-19 was projected on the screen.
The process was explained as follows: In May 2018, the notice was sent to all institutes. Compilation was completed in the mid of June for SBV annual strategic perspective plan.
- ✓ This time the template was mildly modified into categories that was easy to compile and to monitor as well. The members appreciated the efforts of IQAC. The members also suggested if we do the planning digitally for the next year. The MI head, Dr. Jagan would be contacted for the same.
- ✓ The medical education unit was appreciated for their quality-oriented conferences in association with IQAC, the National Medical Education Conference happening this month. The 4th National Medical Education Conference (I-CON2018) Authentic learning innovations for 21st Century Medicos is scheduled for 29th-30th June. The appreciation was recorded for the I-CON conducted in September this year.

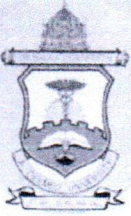
- ✓ CIDRF and IQAC jointly organized the national conference in Environment, Health and Disease, which was well appreciated. This was conducted on 12th Feb 2018.
- ✓ Other quality programs conducted by IQAC was reported, namely the Tools for Quality Assessment and e-portfolio.
- ✓ JAN-MAR QER review was done. The status of research and publications tends to remain the same. The Dean Research was urged to enhance it by innovative strategies.
- ✓ In April 2018, the Pondicherry Institute of medical Sciences sent a letter of intent to collaborate with IQAC SBV and learn from the proceedings of the QER. The session was well appreciated. The Vice-chancellor congratulated the IQAC and wished that they have more such collaborations in the future.

Any Other

- ✓ AQAR data and feedback analysis was reviewed for submission.
- ✓ The feedback obtained in 2017-18 academic year was analyzed by IQAC and the same was presented by the coordinator to the members. The actions taken at the level of the Institutions were projected. Based on the feedback and discussions with the Heads of the Institutions and Centers, certain new programs have been identified to be recommended to the BoM.

1. Bachelor of Physiotherapy is suggested under the AHS. Apart from that 5 more undergraduate programs in AHS will be suggested namely, dialysis technology, medical record sciences, blood banking technology, clinical nutrition, urology technology; all of them to come under the successful implementation of the CBCS in the last year.

2. The nursing principal and pharmacy principal had suggested the commencement of PhD in their respective disciplines.

3. The students indicated the additional training for the NEET examinations and career enhancement programs. It was decided to recommend to the medical and Dental Deans to look into the possibility and commence such courses with appropriate permission from the Vice-Chancellor.

4. IQAC coordinator also recommended a placement cell in all institutions similar to the Nursing institute.

5. Important observation in the feedback was the necessity expressed by the teachers to publish the dissertation of the PG students. Thus, it was decided to recommend to the Deanery research to intensify the training on how to convert dissertation to publications.

The members approved of the above recommendations.

6. It was also decided to have faculty development programs in the E-portfolio and the LMS to deliver both concepts effectively for the benefit of the students.

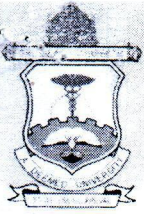

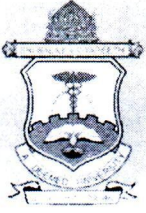



Minutes of the 26th Board of Management Meeting held on 13th August 2018


The Registrar proceeded to table the agenda item wise.

Comments / Recommendations/ Suggestions based on the Action Report of the 25th BoM meeting held on 27/05/2017

- SBV was congratulated for having secured the 83rd rank among Indian Universities, as exemplified by Indian Rankings 2017, published by NIRF, MHRD, Government of India. Further, SBV has improved its India Rankings 2018 as depicted by the 72nd Rank. MGMCRI, the flagship institute of SBV bagged the 23rd position in the top 25 medical colleges of India, as published by India Rankings 2018 by NIRF. **(Agenda 1 under noting)**
- BoM suggested that the Registrar, SBV can send one more request to UGC asking the status of approval of draft MoU between SBV and IMC KREMS, AUSTRIA. **(Agenda 4 under noting)**
- BoM lauded the efforts of the department of Radio-diagnosis, MGMCRI in particular and MGMCRI, in general for having enabled the recognition of the B.Sc (Medical Imaging Technology) by the Atomic Energy Regulatory Board(AERB). 


Comments / Recommendations/ Suggestions [General] of the Board of Management, made at the 26th meeting of BoM held on 13/08/2018

- 1) To prepare a matrix depicting the policy of SBV on academic programmes/ courses at certificate, degree and PG levels [see Annexure 1]
- 2) Decisions taken at the BoM need be reflected in the minutes essentially. In addition, specific communications are to be sent to the Nodal Person/ Contact Person, with the expected timeline, in order to enforce prompt action and feedback.
- 3) Advised to start a fully functional geriatric unit and slowly convert into academic programme (MD, Geriatric Medicine), based on the reinforced clinical services in place.
- 4) Space constraints would ever remain an issue in any major tertiary healthcare system. We need to plan well in advance, taking into due consideration the logistics including space, finance, accessories, workforce etc.

- 5) It is advised that we can enter into a work agreement that would empower organizations to start new super specialty clinics by capitalizing on the existing infrastructure. Since SBV is into the tenth year of existence, since inception, there is a need to promote out-of-the-box thinking and enterprising ideas for all round growth.
- 6) We need to wean away from the thinking that departments, infrastructure and manpower are only for meeting the mandate of regulatory agencies. It is time that we had employed qualified clinical hands who would concentrate on patient care /services and moreover such clinicians need not have to possess the credentials, as per MCI. In other words, SBV could employ subject matter specialists who would contribute to patient care, without even being shown for MCI inspections(Concept of parallel credentialing).

The meeting of the 26th BoM ended with the outgoing Vice-Chancellor Prof K.R.Sethuraman thanking the Chancellor, BoM, Administration, Staff and Students for having given five years of fulfillment and contentment that had witnessed growth and development in the Frontier areas, viz. academics, Patient Care and Research.
